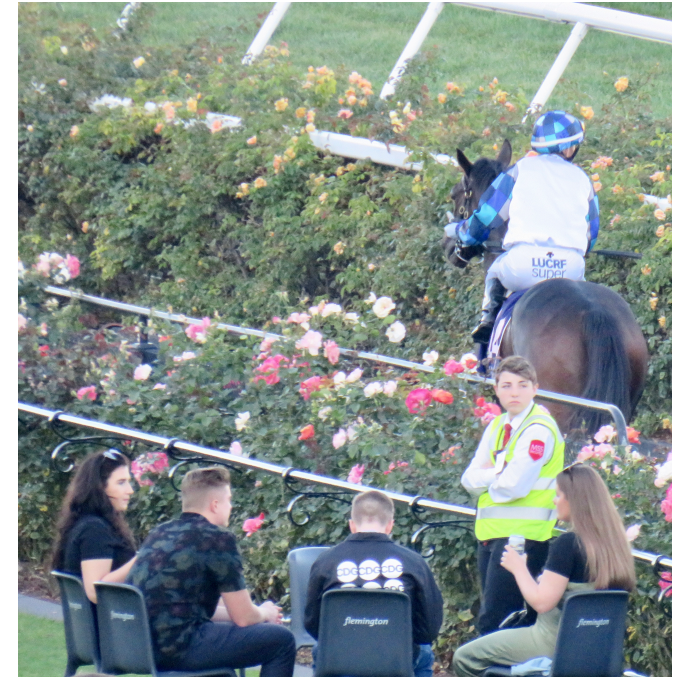
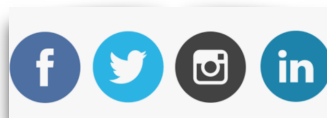

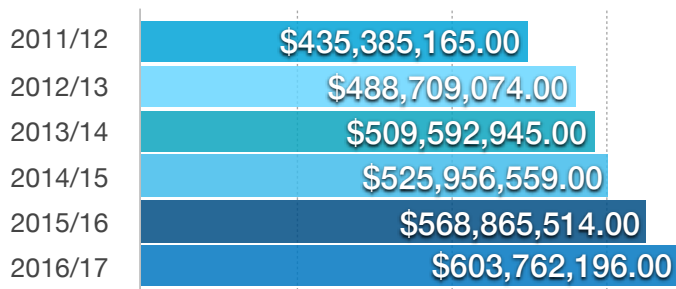

**How much does it cost?**
